DEMOLITION PERMITS – REQUIREMENTS

- SUBMIT BUILDING APPLICATION PERMIT FORM**
- SUBMIT DISCONNECT LETTERS FROM ALL UTILITIES, WATER, GAS, ELECTRIC**
- SUBMIT LETTER FROM LICENCED ASBESTOS COMPANY**
- SUBMIT LETTER FROM PEST CONTROL COMPANY**
- BERGEN COUNTY SOIL CONSERVATION** – As of 11/15/06 Contractors/owners must call 201-261-4407 and submit Engineering Site plans prior to issuance of Demo or Building permit. They will then issue a Soil Erosion Certificate.
- BERGEN COUNTY SEWER CONNECTION FORM COMPLETED.** Form to be completed and returned to the building department. Reply will be sent to the applicant.
- ONE WEEK PRIOR TO DEMO, YOU MUST OBTAIN A DIG # (CALL 811). SUBMIT #**
- A CERTIFICATION LETTER/NOTICE MUST BE SENT TO ALL ADJOINING PROPERTY OWNERS WITHIN 200FT** – State demo start date. List provided by administrative office. Submit a copy of letter & certified slips.
- SUBMIT A COPY OF SITE SURVEY SHOWING ALL TREES ON PROPERTY** – Copy will be sent to the Shade Tree Commission for review. ***NO TREE REMOVAL WITHOUT PRIOR PERMISSION***
- BLANK CHECKS WILL NOT BE ACCEPTED FOR DEMO FEES**
- DO NOT BEGIN DEMO WITHOUT A PERMIT AND NOTICE ON SITE**
- SILT FENCE AROUND PROPERTY** – Site must be maintained properly during construction. Street must be kept clean of all debris and dirt at all times.
