\$2,000,000	General aggregate per location/per project.

Comprehensive automobile liability insurance covering the use of all owned, non-owned, hired or leased automobiles, with limits of liability not less than \$1,000,000 combined single limit for bodily injury and property damage.

Workers compensation insurance as required by the State of New Jersey.

- 2. Cash bond, or other form of security acceptable to the Borough Council, in the amount of \$750.00.
- 3. Owner's written approval for filming on private property.
- 4. Permit fee in the amount of ~~\$1,000.00~~ \$350.00/day.
