SPECIAL NOTE TO ALL DOG OWNERS - The State requires dogs with rabies vaccinations expiring any time before 11/1/2017 must be revaccinated before we can issue a 2017 license. If your pet's vaccination expires in 2017 and you don't take advantage of the free rabies clinic, please note you should still apply and pay for your pet's license in January. It will not be issued until we receive notification that your pet has been vaccinated; however, it will save you from paying late charges.

This notice is a reminder that dog and cat licenses must be obtained during JANUARY, in order to avoid a late charge of \$5.00 per month, per dog/cat. This additional fee will be added for each month of delinquency after Feb. 1st until the license is obtained. Your cooperation in complying before February 1st will be appreciated. The Borough Clerk's Office is open weekdays from 9 AM to 3 PM.

FOR YOUR CONVENIENCE, may we suggest you use the attached mail-in application. In so doing, please remember to include the following:

1. Copies of vaccination and neutering information**
2. Your check made payable to - Borough of Haworth
3. A self-addressed, stamped envelope.
4. Please use a separate application for each pet.



****If this is your dog's first license in Haworth, or if neutering took place during the past year, you must present verification of this when applying for the license.**
